WHAT TO SUBMIT:

Establishments **250 or more employees** – 2018 OSHA Forms 300, 300A and 301

Establishments **20 -249 employees** – 2018 OSHA Form 300A only

Establishments 10 – 19 employees –
Not required to submit (however, must have on hand OSHA records for 5 consecutive years
